AUDIT EXECUTIVE SUMMARY:

Exeter-Ivanhoe Citrus Assn. (Ivanhoe Plant) has 90 workers throughout the season. The operation works from Dec to June. The product was being received in plastic bins. The process included steps such as the receiving, sweat rooms, dumping, dark room, four recirculated washing steps (three kept with free chlorine between 20-200 ppm and pH 6.0-13.0; and one tank with PAA), single pass spray bars with city water (free chlorine 0.1 - 1 ppm), a post-harvest application of Imazalil (diluted with water/recirculated step with PAA between 30-85 ppm), dryer, one packing line, sorting, packing, palletizing, etc. Conventional product. No allergen risks at the time of inspection. This was unannounced audit for three packing houses under the same PGFS number.
